

# DHS Lapse Contingency Plan Summary

## I. Services and programs that will remain operational.

Below are examples of major services that will continue within DHS during a lapse of appropriation along with the reason each is able to continue – either “other funding source” or “necessary for the safety of life and the protection of property”.

## II. Services and programs that will be closed.

- All non-disaster grants programs administered by FEMA and other DHS Components (including state and local preparedness grants)

- NPPD's Critical Infrastructure Protective Security Advisor program
- Federal Law Enforcement Training Center activities would cease.
- State, local, and federal law enforcement and civil rights and civil liberties training
- FEMA Risk-Mapping program
- Chemical site security regulatory program (expired authorization 4 Oct)
- Secret Service authority to continue use of proceeds from and as part of undercover investigations (expired authorization)
- Research and development including improved passenger screening equipment, emergency responder technology and other key investments in homeland security tools

### **III. Key citizen services that will be impacted.**

- E-Verify – Citizens and U.S. businesses will not be able to access E-Verify, the Internet-based system that allows employers to voluntarily determine the eligibility of prospective employees to work in the United States. Over 404,000 employers are enrolled, with more than 21 million queries run through the system during FY 2012.
- FEMA Risk-Mapping – FEMA will cease providing high quality data that is used for public planning which ultimately is used to make insurance determinations for homeowners.
- U.S. Coast Guard services to maritime commerce and recreational boating – The issuance or renewals of seaman documentation and licensing will be delayed, which will impact jobs; fisheries enforcement patrols and routine maintenance to aids to navigation will be limited and/or curtailed.
- Civil rights and civil liberties complaint lines and investigations.

### **IV. Employees.**

- Total Agency Employees: 231,117\* (including 41,364 USCG military personnel)
- Total Exempt Employees: 199,822
- Total Employees Furloughed: 31,295\*
