SUBJECT: Establishment of standard timeline for forwarding the Form I-192,
"Application for Advance Permission to Enter as Nonimmigrant"
to Headquarters Admissibility Review Office (ARO)

(b)(7)(E) An agreement was reached requiring field notification that all Form I-192 applications shall be forwarded to the ARO within 30-days of port of entry receipt from the applicant or his/her representative. Accordingly, effective March 1, 2013, ports of entry accepting a Form I-192 shall forward the application to the ARO within 30 days of submission by the applicant or his/her representative.

Please note the ARO is also required to monitor the timeliness of submission of applications to ensure adherence to the established standard timeline. For this reason, ARO staff will reach out to established field office points of contact if the noted applications are not received within the standard found in this memo.

Please ensure all ports of entry and affected employees in your respective area of operations are informed of the requirements found in this memo and attached muster.
