Pursuant to 20 CFR § 655.120(a), the above prevailing wage rates must be considered in evaluating employer wage obligations under the H-2A program.

Under 20 CFR § 655.120(c)(3), if the prevailing wage rate is adjusted during a work contract, and is "higher than the highest of the AEWR, a previous prevailing wage for the geographic area and crop activity or agricultural activity or, if applicable, a distinct work task or tasks performed in that activity, the agreed-upon collective bargaining wage, the Federal minimum wage, or the State minimum wage," the employer must pay the higher prevailing wage rate upon receiving notice from the Department of Labor.

Therefore, the Office of Labor Certification must evaluate the above prevailing wage rate and promptly notify all impacted employers within the wage reporting area of the wage adjustment and the effective date of the adjustment.

¹ If a prevailing wage survey results in "No Finding" for a particular crop or agricultural activity, the employer must offer and pay the worker(s) the highest of the following: the adverse effect wage rate (AEWR) for the state, the agreed-upon collective bargaining wage, the Federal minimum wage, or the State minimum wage
