Immigration Protection Options for Certain Lebanese Nationals in the United States

Wednesday, Oct. 23, 2024

2 - 3 p.m. Eastern

On Oct. 17, the Department of Homeland Security [announced](#) a planned new Temporary Protected Status (TPS) designation for Lebanese nationals and details related to the Deferred Enforced Departure (DED) for certain Lebanese nationals announced in July. U.S. Citizenship and Immigration Services (USCIS) will hold a national stakeholder engagement related to this announcement on

Oct. 23 from 2-3 p.m. Eastern.

During the engagement, USCIS will provide an overview of DED and how to file for an Employment Authorization Document as previously detailed in the July 26, 2024 [Memorandum on the Deferred Enforced Departure for Certain Lebanese Nationals](#). We will also provide a general overview of TPS for Lebanon; however, we plan to publish additional details in an upcoming Federal Register Notice.

During the upcoming engagement, we will hold a question-and-answer session. USCIS will not address case-specific questions, questions outside the scope of the engagement, or issues under active litigation.
