The Pascua Yaqui Tribe ETC is an acceptable stand alone Western Hemisphere Travel Initiative (WHTI) compliant document for entry into the United States at all land and sea ports of entry. When the card is presented by a Pascua Yaqui traveler, no other documentation is required for purposes of proving identity and citizenship.
