This memo outlines the modifications made to CBP operating systems to support the (b) (7)(E) in regards to the automated I-94.	
On May 14, 2013, the Office of Field Operations (OFO) completed the automation of Form I-94 at air and sea ports of entry. As part of the automation process, arriving aliens can access their most recent I-94 record on the www.cbp.gov/i94 . Although automation was implemented in the air and sea ports of entry only, all I-94s, including those issued at land border ports of entry, can be located on the website. (b) (7)(E)	
Effective immediately, when a port of entry authorizes a (b) (7)(E) disposition should be selected as the disposition code during the inspection close out. The (b) (7)(E) disposition code will create an I-94 record, but (b) (7)(E) the I-94 record on the I-94 website. The (b) (7)(E) code does not assign an admit until date in the system. The admit until date must be entered by the officer in accordance with existing SOPs.
