INFORMING DAF APPLICANTS ON BMT NATURALIZATION

PURPOSE

- To explain how AFRS informs prospective Airmen/Guardians who are Legal Permanent Residents (LPRs) on the U.S. Naturalization process

BACKGROUND

- LPRs are immigrants admitted for permanent residence to live and work in the United States. LPRs are issued a Permanent Resident Card INS Form I-551 for a period of 2 years (conditional) or 10 years (without conditions).
- Currently, recruiters may enlist LPRs that hold a 10-year card and have at least 6 months or more remaining before expiration.
- LPRs may qualify for naturalization based on military service, which can be completed using the BMT Naturalization Program.
- Recruiters inform all LPRs of the opportunity to become a U.S. citizen through military service and provide the applicant with the following attachments and links to learn more:
