ICE appoints family residential center federal advisory committee members



WASHINGTON – U.S. Immigration and Customs Enforcement (ICE) announced today the list of appointments to the Advisory Committee on Family Residential Centers. The committee was established July 24. Members will draw on their diverse experience to advise the Department of Homeland Security and ICE on matters concerning family residential centers.

The committee's charter requires that membership consist of up to 15 members, representing a variety of perspectives, with at least one representative from each of the following disciplines: primary education, immigration law, physical and mental health, trauma-informed services, family and youth services, detention management and detention reform.

"I am very pleased with the caliber, qualifications and diversity of the committee members," remarked ICE Director Sarah R. Saldaña. "The responsible management of our family residential centers is chief among the agency's priorities and I trust this group will contribute invaluable insight and advice to that end."
